

Merriwood Christian Camp ~ Financial Scholarship Application 2023

Amount of Scholarship: All financial scholarships are partial (not full) scholarships. Generally, qualifying campers receive 10% - 50% off the session fee as a scholarship amount. Limited scholarship funds are available for campers with financial needs. MCC will only provide financial assistance for one session (week of camp) per camper per summer season. If the camper desires to attend additional sessions, the additional sessions must be paid for in full. All remaining summer camp balances are due two months before the start of the camp session. A \$25 late fee will be assessed if the balance is not paid within one month of the camp start date. If you attend Merriwood with your church group, we first recommend you contact your church to see what assistance they may be able to provide.

Please note that a child is not registered for a week of camp (i.e. a space is not reserved) until the \$75 deposit has been received. Spaces fill up quickly for some weeks. We are unable to hold a space in a particular week until we have the registration form and \$75 deposit. Please allow our staff at least two weeks to process your application.

<u>Deadline:</u> Scholarship applications must be received at least three weeks prior to the start of the camp week in order to allow time for processing.

<u>Additional Documents Needed:</u> Along with this application, you must submit a copy of your latest completed income tax returns and copies of your two most recent paycheck stubs (as well as verification of child support, if applicable). These forms can be uploaded through the Document Center (log into your registration account, Document Center is found under "Additional Options") mailed to the camp office, or emailed to registration@campmerriwood.net.
