

Michigan Children's Camp Central Registry Clearance Instructions

A Central Registry clearance is required for Children's Camp staff and unsupervised volunteers who are 21 years of age or older. To request a clearance, go to www.michigan.gov/ccbc-camps and click Create New Account. If you have previously made an account, you should proceed to log in.

This website is specifically for **staff and unsupervised volunteers** of Michigan-licensed Children's Camps and Campsites who are **21 years of age or older** and require a **Central Registry clearance** to work or volunteer at camp.

Re: Children's Camp Central Registry Clearance

Dear **JACOB POYNTER**:

You requested a central registry clearance be performed on you for the purposes of working or volunteering for a licensed Children's Camp or Campsite. The results of this search indicate that as of **5/1/2025** there is **no record** of you being identified as a perpetrator of child abuse and/or neglect on the Child Abuse/Neglect Central Registry system in the State of Michigan.

If your request was denied, you should **not** send your letter to the camp. The letter details how to request an expungement of a Central Registry case. Once expunged, you can submit a new Central Registry clearance request to the CCBC Unit.
