Waiver, Assumption of Risk and Indemnity for Private Property Rentals

My Girl Scout member is participating in a Girl Scout activity that includes plans to stay in one or more private rental properties, either rented directly through a private owner and/or rented through a short-term rental platform such as Airbnb, VRBO or HomeAway (collectively, "Private Rental Properties"). I understand that there are known, and unknown risks associated with Private Rental Properties and understand and am aware that neither Girls Scouts of the USA, nor Girl Scouts of Northern California, conducts screening of nor assumes any responsibility for Private Rental Properties. Such risks include, and are not limited to:

- Unsafe conditions, including physical and fire safety and lack of support in an emergency;
- Security concerns, including hidden cameras, and break-ins;
- Failure to comply with local laws applicable to short-term rentals;
- Issues with the property owner/host, including last minute cancellations, no refunds, photos don't match reality, bait and switch from rented accommodation to an inferior accommodation; and
- Lack of insurance coverage for claims and injuries arising out of the rental.

Waiver. In return for being permitted to participate in Girl Scout activities at Private Rental Properties, I, for myself, heirs, personal representatives, and assigns, assume all risks and release, waive, and discharge, Girl Scouts of the USA, Girl Scouts of Northern California, and/or any of their directors, officers, employees and agents ("Girl Scouts"), from liability from any and all claims, resulting in personal injury (including death), accidents or illnesses, in connection with our troop's rental, use, and/or enjoyment of one or more Private Rental Properties for Girl Scout activities.

Acknowledgement of Risks and Responsibilities Related to Private Rentals, including through short-term rental platforms. I have read and understand, and agree to adhere to, the <u>Volunteer Essentials</u> and <u>Safety Activity Checkpoints</u> for Private Property Rentals, including through short-term rental platforms, such as Airbnb, VRBO, HomeAway, including, but not limited to, the obligations to inform participants and required forms to assume risk and hold harmless GSNorCal.

I have read this Waiver, Assumption of Risk and Indemnity for Private Property Rentals document, fully understand its terms, including, that I am assuming all risks of renting and/or using Private Rental properties, and, with respect to any such rentals, use, and/or enjoyment am: (a) releasing Girl Scouts from all liability, (b) waiving any right to sue my right to sue Girl Scouts, and (c) indemnifying Girl Scouts. I further agree that if any portion of this Waiver, Assumption of Risk and Indemnity is held to be invalid, the remaining portions will continue to have full legal force and effect.
