Organization goals and Camper development objectives

Goal # 1: To enable children to enter into a personal relationship With Christ and to know His Word.

Objective: Campers will have the opportunity to recognize and act on the need for

Personal acceptance of Jesus Christ as Savior.

Objective: To enable children to enter into a personal relationship with Christ and to

Know His Word.

Requirements:

Morning Watch:

- Campers will learn to have a quiet time alone with God by spending 10-15 minutes in the morning reading the Bible and praying. Setting: outdoors, if weather permits.
- Campers will use material that explain the message of salvation and encourage them to establish a pattern
 of daily bible Study, Scripture memory, and prayer.
- Morning Watch materials must be approved by the Association of Cederbrook Camps (ACC)and Pioneer Clubs.

Bible Exploration

- Campers will participate in a counselor-led small group Bible study each day. These studies will include opportunities for active involvement in the learning process and for practical application to everyday living.
- Bible study curriculum must be approved by the ACC and Pioneer Clubs

Campfire Massages

• Campers will have the opportunity to hear Scripture-based campfire message which apply Scripture to daily life and encourage non-Christians to enter into a personal relations with Christ.

Worship Service/Vespers

Campers will participate in a weekly worship service.

Cabin Devotions:

 Cabin groups will participate in a brief devotional time each night. This may include a Scripture or devotional reading, prayer time and opportunities for interaction and sharing. This may also include a discussion ofsalvation that encourage campers to make a personal decision for Christ.

Songfest:

• Songfest should include spiritual songs that emphasize Scripture, scriptural principles, Christian experience and worship.

Follow Up

- Campers will be able to meet with their counselors to talk about their spiritual walk and salvation experience with opportunity given to make a decision if desired.
- · Camp will provide appropriate follow-up for those campers who make decisions for Christ.

Activities

• Campers will be encouraged to practice Christian principles and behavior while participating in all phases of the camp program.

Leadership

- Each staff member will have nade a personal commitment to Christ.
- Staff will be given training in leading a camper to Christ.
- Counselors will be instructed to meet with camper on an individual basis to get to know each one by listening to the camper and discussing his or her spiritual walk.
- Staff will be trained in giving campfire messages, leading songfest and combining these two elements with the activity time to produce a unified evening program.
- Staff will be encouraged through training and supervision to model a biblical life-style and will have opportunities for personal growth through staff Bible study and prayer time.
- Staff will encourage campers to apply Christian principles to ever phase of their camp life.

Other Suggested Program Elements/Follow-up

- Christian literature may be made available to campers in the Tuck Shop (camp store) and/or camp library.
- Camp may wish to provide appropriate follow-up materials such as information about local Pioneer Clubs and churches, Bible study material etc.

Goal #2: To enable children to form healthy relationships

<u>Objective:</u> Campers will have the opportunity to practice biblical principles of community living which enables them to develop positive relationships, to learn to work with others, to accept responsibility within a group and to develop decision-making skills

Requirements:

Cabin Groups

- Campers will experience leadership opportunities, decision-making, self-initiated activities through planning activities for their own cabin group.
- Camp Cherith will accept campers regardless of race, religion, or culture. As much as possible, cabin groups will be made
 of campers from a variety of backgrounds within the same age group.
- Counselor/camper rations will comply with the ACA standards.

Evening Activities

 Campers will participate in evening activities designed to foster appreciation of different skills and abilities in others, cooperation, decision-making and leadership.

CILT Program

Qualified Explorers will be given the opportunity to participate in this special leadership development program.

CAPERS

• Campers will share responsibility for maintain cleanliness in individual and community areas.

Dining Hall

· Campers will follow established procedures that encourage community cooperation and consideration for others.

Leadership

- Train staff in building relationships, fostering communication and facilitating group process.
- Train staff to take advantage of teachable moments.
- Train staff in positive methods of conflict resolution
- Train staff to model biblical principles of community living, positive relationships, working with others and leadership.
- Encourage staff to allow campers to plan groups activities when possible
- Provide staff with resources that will spark creative ideas for groups activity and individual accomplishment.

Other Suggested Program Elements

- Campers may experience leadership opportunities through all or some of the following camper-planned activities: cookouts, overnights, songfests, etc.
- Family-style eating 9encourage courtesy and etiquette)
- Camper work crew program
- Camper activity assistant program
- Cabin leaders

Goal #3: To enable children to grow as whole persons.

Objective: In activities, campers will have the opportunity to : have fun, increase skill, Build confidence and develop a sense of accomplishment and self-discipline.

Objective: Campers will develop a sense of their individual uniqueness and Godgiven worth.

Objective: Campers will have the opportunity to develop a greater appreciation for God's creation by learning to care for and enjoy the outdoor environment.

Requirements

Activities

- Campers will have the opportunity to choose from a variety of activities designed to meet the needs and interests of different age levels.
- Campers will have the opportunity to learn skills, progressing from beginning to advanced levels, in a non-competitive atmosphere.
- Campers will receive guidance in choosing activities and will be encouraged to develop new skills.
- Campers will have the opportunity to earn achievements and receiver recognition for those achievements.
- Campers will have the opportunity to strengthen their self-concept through focus on individual achievement and progress
- Campers will receive individual attention and positive affirmation.
- Campers will have opportunities for creative expression
- Campers will have opportunity to learn about the outdoor environment
- Campers will participate in activities unique to a camp setting.
- Program will be structured to include as many outdoor activities as possible
- · Campers will have opportunity to learn outdoor living skills

Outdoor Living

- Campers will participate in at least one cookout each week
- Campers will have the opportunity to sleep out-of-doors
- Campers will take responsibility for environmental conservation of the campsite.

CILT Program

• CILT's will have the opportunity to choose from a variety of activity specializations

Songfests

Songfests will include fun songs, bridge songs and spiritual songs which emphasize a theme

Group Living

- Counselor/camper ration must comply with ACA standards
- Campers will meet individually with their counselor at least once a week to share about their spiritual walk, camp
 experience and other concerns.
- Campers will have the opportunity to interact with others.
- The daily schedule will be flexible enough to allow for additional self-initiated cabin groups activities
- Campers will share responsibility for cabin and camp clean-up

Health and Safety

- Camp will plan and provide balanced meals
- Camp schedule will include a balance of activity and adequate rest for campers and staff thus ensuring Necessary energy levels for positive interaction
- Campers will be informed of site boundaries, facilities, natural hazards and danger areas

•

- Health care personnel must comply with ACA standards in regard to an overall health care plan,
 Standing orders, staff certifications, screening, record-keeping, infirmary and storage of medications.
- Camp will provide necessary and loving care in the event of routine medical care, illness or accident
- Emergency procedures complying with ACA standards, are written in policy manuals and practiced each week.
- Camp administration will maintain ACA standards for health and safety.
- Staff will teach and enforce safety practices.
- Staff will be alert to campers' need for independence but will intervene in situations that are physically or emotionally threatening.

Leadership

- Counselors and activity leaders will emphasize personal achievement, rather than competition.
- Counselors and activity leaders will be encouraged to create an enjoyable learning atmosphere.
- Staff will be trained in activity skill. Qualifications and national certification will be documented.
- Camp will adhere to national organization standards (ARC, CAA,NAA,CHA, NRA, etc) where Available and appropriate
- Camp administration will keep counselor's non-counseling duties to a minimum and provide sufficient time in the daily schedule for interaction with campers.
- Staff will be trained in outdoor living skills in order to feel comfortable and secure in handling outdoor activities.
- Staff will be given experience and training in nature awareness.
- Cookout leaders will be taught principles of fire-building, safety and outdoor cookery

Other Suggested Program Elements

- Trip program
- All camp nature activity opportunities
- Nature center or other self-initiated activities
- Environmental conservation service projects

Goal #4: To enable adults to understand children and help them develop

Requirements for this goal have been incorporated into all of the above objectives
