Additional Information & Requirements

One-way from PSR to Riverside, Loma Linda, or Escondido is not available.

Campers on transportation must have completed all required forms (medical, liability agreements, waivers, etc.) and be paid-in-full before they are allowed to board the transportation vehicle.

Campers will also have to pass a health screening before they're allowed on transportation. This screen mostly revolves around determining if your camper has lice, a serious injury, or a high temperature.

Please do not call camp to adjust your transportation on Sunday morning. Last minute changes delay the bus/van/truck from reaching their location and affect the wait-times of other families. We're happy to adjust transportation requests Monday-Friday to fit your needs.

Where's the Bus/Van/Truck?

PSR Christian Youth Camp is happy to provide transportation for our 2019 session. Please allow up to 20 minutes for late arrivals and departures. If transportation does not arrive within 20 minutes, please call (951) 659-

3173. If there is an emergency, parents will be notified as soon as possible, at their cell phone number listed in our registration software.

Please note: Departure times are approximately half an hour after the drop off time listed above.

Bus/Van Rules & Guidelines

Camper supervision is the responsibility of the parent/guardian before and after drop off & pick up. Unsupervised children will not be allowed to board any camp vehicle.

Early boarding is not available. No camper will be checked in until the time listed.

Campers should not approach an arriving van or bus. They should only board after being given permission by the driver.

Eating on the bus or van is not permitted, Sunday dinner will be served at camp. If your child is prone to motion sickness, please consider providing a sickness bag or the appropriate medicine.

If applicable, campers under 40 pounds must be placed in an approved restraining device, i.e. a car seat.

For their own safety, campers must abide by all bus or van rules:

- Watch your step when boarding and unboarding the vehicle.
- Please remain seated, wearing your seatbelt at all times.
- In the event of an emergency, please remain calm and wait for instructions.
- Keep all parts of your body inside the vehicle at all times.
- No shouting, screaming, or fighting is permitted.

PSR Camp is currently unable to provide transportation for the physically disabled. If your camper meets the qualifications for camp, but is disabled, please plan to transport them yourself and request a full refund for any fees collected by PSR Camp for transportation.
