



## PSR CAMP RELEASE, CONSENT, & ASSUMPTION OF RISK FOR BOTH PARENT AND CHILD

### Supervision of Children during PSR Family Camp

During PSR Family Camp, minors must be supervised at all times, whether by their Parent(s), or their Adult Guardian(s). PSR is not responsible for the supervision of any child(ren). Parents and/or Adult Guardians may not leave PSR grounds without their children and/or minors under their care.

### Statement of Risk

The staff at PSR has made every reasonable effort to make camp as safe as possible. However, all camp activities (including, but not limited to: ropes challenge course, rock climbing, swimming, archery, mountain biking, hiking, go-carting, skateboarding, marker tag, field sports, basketball) have inherent risks, and may result in serious injury or death. Participation in any camp activity is voluntary and at your own, and your child's own, risk.

### Consent, Release, and Assumption of Risk

I, the parent/guardian of the child(ren) named below, having legal custody of the child(ren) attending PSR Family Camp, give my consent for the child(ren) to participate in PSR Family Camp program and activities. In giving my consent, I agree to the following: A. I acknowledge that I have been informed of the inherent risks of the camp activities that my child(ren) and I will participate in, and agree to abide by all PSR rules and safety guidelines. B. I release Pine Springs Ranch (PSR) and Southeastern California Conference of Seventh-Day Adventists, their employees, agents, and volunteers, as well as their affiliated organizations (SECC) from any and all liability and responsibility for any loss or damage to property and/or any injury or death to person(s) that may occur during PSR Family Camp. C. I agree to indemnify and hold harmless PSR/SECC from any and all claims, damages, injuries, and expenses arising out of or resulting from my child's or my own participation in any camp activity or program and release, acquit, and covenant not to sue PSR/SECC for any and all actions, causes or action, claims, damages, damages-in-law, or remedies in equity of whatever kind, including negligence of PSR/SECC. D. I accept and assume full responsibility for the risk of property loss or damage and/or bodily injury or death, whether caused by PSR/SECC or otherwise, and whether due to the negligence of PSR/SECC or otherwise.

### COVID-19 Acknowledgement

I, the parent/guardian of the child(ren) named below am aware of the health and safety protocols being implemented by PSR, and I agree to participate along with those named below in the activities and programs despite the risk of exposure to COVID-19. I will report any symptoms of illness from anyone in my group/family to the PSR nurse/doctor and Executive Director. I shall report to the PSR nurse/doctor and Executive Director if anyone in my group/family has any contact or exposure to COVID-19.

**Promotional Release** I give my express permission to PSR to use my child's or my own image, picture, or other likeness for promotional purposes without compensation of any kind.
