Dear Camp Families,

I am thrilled that you are joining us for camp this summer! First of all, a huge thank you for participating in the Camp Preferences Survey and for completing your background checks quickly! All campers have cleared. Please see the travel section below and plan your travels. And from the bottom of our hearts, thank you to the many who donated to make the expanded camp a reality!

REGISTRATION CHANGES & CONFIRMATIONS

The deadline to make ANY changes to your camp registration, including horseback rides, is Sunday, March 1. If you chose the payment plan during registration, the balance will be charged to your card on file on March 1. If you need to cancel your reservation, please email me immediately to provide the best opportunity of finding a family to take your spot.

It is imperative that you log into your UltraCamp account TODAY and confirm the following information is accurate.

- ACCOUNT ACCESS:** Access your account via www.ListenFoundation.org/CampAccounts. If you have forgotten your username/password please use UltraCamp's "Forgot your login information?" link. I do not have access to usernames or passwords. Menu bars in the upper left corner of your UltraCamp account page may be used to navigate between pages.
- PARTICIPANTS:** From the "My Account" page, select "My Reservations". Under "Reservation History" select "June/July Listen CI Camp" and **confirm that each family member who will attend camp, regardless of age, is listed under "Attendees". Attendees are limited to 5 per family and include: the CI child(ren) age 3 years - 2026 high school graduates, parents/legal guardians, and siblings up to 2026 high school graduates. We are unable to accept walk-in registrants and those outside these parameters.** Please use the "Edit Participants" link, "Update Participants" button, and "+ Add Person" button as needed. Be sure to select "Save" after adding each attendee.
- ATTENDEE INFORMATION:** From the "My Account" page, under "Account Members", please select the first family member who will attend camp, then select "Edit My Bio Information". Once on the individual's page, scroll down to "Additional Information" and please ensure that the following are accurate. **This information cannot be changed after March 1:**
 - Individual's Relationship to the CI Child**

- b. **Fall 2026 School Grade:** Your child will be grouped based on the **Fall 2026 grade**. Group changes are not permitted.
 - c. **T-shirt Size**
 - d. **Support & Accommodations:** Does any member of your family need support or accommodations to participate fully and safely? This may include a crib, high chair, wheelchair accessible room, food allergies, or medical, cognitive, or emotional factors. If no support or accommodations are needed, please enter "N/A".
 - e. **Be sure to select "Save" at the bottom of the screen and repeat this process for each family member attending.**
4. **STABLE PURCHASES: For many of you, the stable activities you attempted to purchase were not recorded! Please confirm your stable activities by following each step below:**
- a. From the "My Account" page, select "Reservations". Then under "Reservation History" select "June/July Listen CI Camp" and scroll to "Options".
 - b. Under "Options" **if rides are listed, but the \$ amount for those rides was NOT added to your \$ total, you are not registered for your rides.**
 - c. To register for your rides, please select "Edit" from the "Options" section. **Scroll down to your selected rides, click on the checkbox in front of "Qty", AND enter the correct number of rides you wish to purchase from that category.** Repeat this process for each category from which you wish to purchase rides.
- Qty. 2 Trail Ride – Post-Camp Sunday Arrival Time 8:30am - Ages 13 and Above - Maximum Weight 230 Pounds
- Checkbox must be checked AND quantity must be correct.**
- Stable activities are limited to 1 per family member.** Select "Next" at the bottom of the page.
- d. Confirm that the \$ amount for your rides was added to the \$ total.
 - e. If you requested a stable activity prior to or after camp, be sure to **schedule your travel to accommodate the arrival time you selected.** If you purchased pre-camp rides, please go directly to the stable upon arrival at the YMCA.

TRAVEL INFORMATION

- You will find all things camp including travel information and a "Camp Packing List" at www.ListenFoundation.org under the "CI Camp" tab.
- Check in for Listen CI Camp runs from 3:00-4:30pm (MT) Thursday, with activities beginning promptly at 5:00pm (MT). Campers depart Sunday morning no later than 9:30am (MT).
- To make the most of our time together, days are intentionally full of recreational activities carefully selected to facilitate bonding and learning from each other. It's your participation with other families that makes camp so special- camp isn't camp without you actively engaged! If you would like to explore Rocky Mountain National Park or other offerings at the YMCA, please make arrangements to stay in the area a few extra days before or after camp for your family vacation.

- The Listen CI Camp Parents Facebook group is a great way to get to know others before camp. I encourage you to introduce your family! Also be sure to watch the Listen CI Camp Facebook page. We'll introduce the volunteers there in the weeks leading up to camp.
