2. Any work performed by Participant and any minor children as volunteers becomes the sole property of the AFC;

3. The AFC makes no warranties or assurances as to the facilities or equipment utilized by Participant or any minor children;

4. Participant agrees and does hereby hold blameless, exonerate, release, and indemnify the AFC from any and all liability or claims, demands, damages, costs, loss of services or expenses or compensation for or on account of any damage, loss or injury either to person, including minor children to which Participant is legal Parent or Guardian, or to property which we may have against the AFC or its members arising out of our attendance and/or participation in the Holy Family Fests or other programs or events whether or not it be caused by the negligence of the AFC or its agents or employees or otherwise;

5. Participant and any minor children will follow all of the printed or posted rules and regulations as they appear around AFC property, as well as any materials provided to participants at registration and check-in.

COVID-19 Release of Liability: I am apprised of the COVID-19 pandemic and assume personal risk in choosing to engage or allow my minor children to engage in any specific religious gathering, including attendance at an AFC activity. I do not hold the AFC responsible for any injuries, illness, or financial liability resulting from COVID-19 that may have been contracted by myself or my minor children while attending an AFC religious gathering. I agree that myself and my minor children will abide by posted directions and those communicated to me at check-in and during other announcements before and during my stay at the AFC facility as they may relate to COVID-19. I certify that myself and my minor children have self-assessed for COVID-19 before traveling using CDC guidance, and will do so every day we remain on AFC property. When necessary, I will inform the AFC of any legally acceptable exceptions that I or my minor children have regarding mandated face coverings while on AFC property.

Refunds will not be provided to any individual who is removed for refusing to comply with any communicated AFC standards.
