

## PASSENGER ASSUMPTION OF RISK AND RELEASE OF LIABILITY AGREEMENT

This Passenger Assumption of Risk and Release of Liability Agreement is entered into on the date below written by and between Skyborne Aviation Training Ltd (trading as Skyborne Airline Academy) and ,  
herein after referred to as passenger.

- Assumption of Risk.** Passenger acknowledges that participation in an aircraft flight is voluntary and also acknowledges, by his/her signature below, that these flights are a potentially hazardous activity and that accidents, sometimes serious in nature occasionally occur during flight, in preparation for it and during landing due to known or unknown risks and dangers. Passenger is aware that some of the risks, which are inherent in potentially hazardous activities such as aircraft flights include, but are not limited to, bodily injury or death to himself/herself, others or any participating minor within his/her care and control and loss or damage to property. Passenger acknowledges that he/she accepts all risks involved which necessarily arises from participating in this flight.
- Release.** The passenger, on behalf of him/herself and/or his/her representatives. Hereby voluntarily releases and discharges Skyborne Aviation Training Ltd, its employees and all other persons or entities associated with Skyborne Aviation Training Ltd from all liability, claims, demands, causes of action for bodily injury, death, illness, diseases or damages to myself, others, or any participating minor within my care or control, to my property, which is related to, or arises out of my participation in an aircraft flight, including but not limited to those arising from any negligent or careless act(s) omission, breach of contract, or defect(s) in equipment used.
- Medical Statement.** I hereby certify that I have no physical or mental defect and/or condition which would prevent me from participating in an aircraft flight and/or related activities.
- Rules.** I agree to follow all rules and instructions of any and all employees, and all other persons or entities associated with Skyborne Aviation Training Ltd regarding the flight in an aircraft and/or related activities.
- Legal Capacity.** I certify that I am 18 years of age or older or that I have the consent of a parent or guardian to participate in an aircraft flight. I acknowledge and agree that by signing this agreement and release, I am giving up my right to sue the released parties for any damages or injuries I suffer, or any child within my custody and/or control suffers, while participating in an aircraft flight at Skyborne Aviation Training Ltd, even if the released parties negligently cause my damages or injuries. I have read and understand this entire document. It is effective and binding upon me, my heirs, assigns, personal representatives, estate and any child within my custody and/or control who is participating in the flight.
