

Adult Camper & Child Camper Agreement

Weekend and Long Weekend Camps



Parent/Caregiver, Child Campers, and Supervising Adults:

The safety and wellbeing of our campers (child and adult) is our number one concern. Therefore, this camp agreement has been developed to help you and your campers, group, or family understand our safety regulations at camp. We ask that you and your campers read over this camp agreement. Please supply a copy of this agreement to every parent/caregiver and camper in your troop, family, or group. You do not need to sign this agreement and return it, but you and your family or group are expected to comply with this agreement:

We agree that everyone in our group or family will attend camp and follow all rules, regulations and safety guidelines.* We also understand that if while at camp anyone in our group or family prevents the staff from safely supervising us and/ or others or becomes harmful to ourselves, to campers or to staff, we will be in violation of this camp agreement and could be sent home from camp. If this situation does occur, we understand that we or the designated emergency contact person (if parent/caregiver cannot be reached) will be responsible for taking our camper(s) home from camp. If anyone in our group is sent home from camp, we understand that there will be no reimbursement monetary or otherwise.

As parents/caregivers, campers, and supervising adults, **we agree to** and accept all rules, regulations and safety guidelines provided for our group or family as set forth by camp.* We also agree that as parents/caregivers, campers, and supervising adults, we will not make any unreasonable demands of camp in relation to our group's and campers' participation at camp.

Participating Camper (whether family member, Girl Scout camper, or supervising adult camper):

As a participating member at camp, **I agree to** adhere to all rules, regulations and safety guidelines set forth at camp.* I understand that if I put the safety of other campers, staff members or myself in danger or if I prevent the staff from safely supervising me or others, I will be in violation of this camp agreement and will be sent home from camp.

Communicate understanding with each camper, adult or child, in your group/family:

My camper(s) and I have read, understand and agree to the terms and conditions of this camp agreement.

***Rules, Regulations and Safety Guidelines**

1. Have fun, make friends, and enjoy lots of laughter.
2. Campers will be respectful of themselves and others at all times.
3. Campers will not verbally or physically threaten, abuse or harm other campers and or staff at any time while at camp. **
4. Campers will be respectful of others' personal property.
5. The use of alcohol, non-prescribed drugs, and tobacco is strictly prohibited.
6. Campers will be respectful of all camp property and equipment.
7. Campers always travel (whether on or off the camp property) with a buddy.
8. Cell phones, portable TVs, iPods, iPads, MP3 Players, personal sports equipment, pets, as well as weapons of any kind are strictly prohibited. Supervising adults/Adult campers will keep cell phones or other technological devices out of sight of all campers (adults & children) and staff at all times. Adults, please bring a watch to set alarms and keep track of time.
9. Supervising adults and attending parents are responsible for chaperoning their child campers at all times and ensuring every camper in their group is abiding by the camper agreement including all rules, regulations, and safety guidelines. Adults, consider bringing a copy of this agreement with you to help remind your group or family.
10. Campers are required to participate in all aspects of camp life (i.e., unit and all- camp kapers, all-camp activities, emergency practice drills, etc.).
11. Campers, including adults, will not pack or bring to camp: gum, candy, cookies or snacks of any kind.

****Parents/guardians**, the aforementioned safety rules, regulations and safety guidelines are put in place for the safety of our camp patrons. Our staff will work with your child to make sure that these safety regulations are followed and that everyone at camp has an enjoyable experience. However, there are some displays of behavior or actions that are unacceptable and require action that may require the immediate action of a parent, guardian, or other designated "Camp Pick-Up"
