

## **Acceptance Information**

Dear Parents,

We are looking forward to seeing your child at Camp Bird! The following information should assist you in preparing your child for a safe and fun-filled week at camp.

---

### **Arrival and Check-in Instructions**

Camp Bird's address is:  
N8395 Caldron Falls Rd  
Crivitz, WI 54114

We are located halfway between Crivitz and Mountain on County W. Take County W for 17 miles west of Crivitz or 15 miles east of Mountain. Turn north on Caldron Falls Road. After about a mile and a half, you will see the camp entrance on your left. Park in the parking lot, bring your camper's belongings with you, and follow the posted signs to the dining hall for check-in. There you will receive your camper's cabin assignment and check in with the nurse if necessary. Have your camper's medication ready, if applicable.

Check-in is staggered and will be done as follows:

- Girls in grades 5 & 6 may arrive at camp and check in beginning at 2:00pm
- Girls in grades 7 & 8 may arrive at camp and check in beginning at 2:30pm
- All boys may arrive at camp and check in beginning at 3:00pm

*We understand that families will bring their campers of different ages at the same time and we will of course be flexible with this schedule to accommodate all campers within a family arriving at the same time.*

### **Medication Instructions - Please read carefully!**

**The State of Wisconsin regulates storage and administration of medications at children's camps to keep children safe. Our nurses comply with all laws pertaining to your child's medications.**

- Any *prescription medication* that your child needs to take during the week must be given to the camp nurse at check-in, **inside the original container from the pharmacy.**
- Send the **original bottle or container** of medication with the appropriate number/doses of prescribed medications inside.
- Please provide enough medication for your child for 6 days.
- **Do not bring your child's medication in any other container. The nurse may not administer medications to your child if the medication is not in the original**

**container with the name of the medication, dose, route and frequency of administration.**

- All prescription medications that your child takes “as needed”, must have the **reason** your child takes the medication listed in the medication instructions from the child’s primary care provider (Physician or Advanced Practice Provider, such as a Nurse Practitioner or Physician Assistant).
  - Place the original bottle or container of medication in a plastic resealable bag with the child’s full name on the outside of the bag.
  - The primary care provider’s signed Physical Form must include written dosage instructions for the nurse and that must match what is entered into the medication section of the registration application.
  - **DO NOT** bring over-the-counter (OTC) medications, unless your child takes an OTC daily. The nurse has commonly used OTC medications and will administer these medications per your child’s request and the nurse’s discretion.
  - Hand-held inhalers **are allowed** in your child’s cabin and under their control to take as needed.
  - All other medications **are not allowed** in the campers’ cabins.

### **Mail Instructions**

Every dinner we have “mail call.” Please don’t mail anything after Tuesday as it will not get to camp in time to be delivered to your camper. You may address letters to your children as follows:
