Welcome to Adventure Academy

Adventure Academy offers a wide variety of activities, including swimming, archery, hiking, low-ground team building, adventure elements, crafts, and nature-based experiences.

All campers will have the opportunity to experience both our indoor and outdoor climbing walls, as well as signature adventure elements such as the ravine crossing zipline, Giant's Ladder, Flying Squirrel, and Pamper Pole. Each group will also visit ZipZone Outdoor Adventures ("ZipZone"), located on camp property, to explore their Adventure Park.

Base Camp B groups will also participate in our high ropes course. Due to age requirements, Base Camp A campers do not participate in the high ropes course.

Schedule

- Monday – Thursday: 9:00 AM - 4:00 PM
- Friday: 9:00 AM - 12:00 PM
 - Campers who have registered and paid for the ZipZone add-on will remain at camp until 3:00 PM.

Lunch Daily at approximately 11:45 AM

Swim (Monday - Thursday) 2:50 PM – 3:50 PM

We welcome campers back Friday for Capture the Flag and our final bead ceremonies. Pick-up is at NOON (not 4:00 PM!) on Friday unless you have registered and paid for your camper to participate in the ZipZone Add-on. In that case, pickup is at 3:00 PM.

What To Bring

- Reusable/refillable water bottle
- Sunscreen and bug spray
- Swim gear, goggles & towel
- Flexible, comfortable footwear. Footwear must be closed-toed, no Crocs. Tennis shoes/sneakers are preferred.
- Casual, layered clothing appropriate for the weather. Jacket or rain gear when necessary.
- Face mask (if desired)

What to Leave at Home

- Cell phones, smartwatches, and other electronic devices
- Soda, juice, gum, candy
- Pocket or camping knives (or other weapons)
- Flip-flops, Chacos (or other open-toe shoes), Crocs
- Anything you are not willing to see get dirty / damaged such as shoes, clothes, personal belongings

“Leave at home” items that make it to camp will be secured and held until the end of the day, no exceptions. Godman Guild and Camp Mary Orton are NOT responsible for reimbursement or replacement of personal property that is brought to CMO.

Lunch and Snacks

Camp will provide all campers with lunch supplied by Blue Bow Tie catering. Campers will also be provided with a morning and afternoon snack. If your camper generally has more than one snack in the morning or afternoon, additional snacks will need to be supplied from home.

Adventure Academy curb-side drop-off & pick-up

Adventure Academy drop-off and pick-up occurs in the main CMO lot. We will have signs and staff in place to help you get to this location and traffic cones for car lines.

Adventure Academy will begin signing campers in at 9:00 am and out at 4:00 pm. Our staff begins each day with a team meeting and are not available for an earlier drop-off. If you have a sibling at Discovery Day Camp, please drop them off in the right-most lane. Adventure Academy Campers will need to stay with you until their camp begins.

During drop-off and pick-up, *please stay inside your vehicle*. CMO staff will meet you at your vehicle to check your camper in or out for the day. *For everyone's safety, campers should not exit or enter their vehicle until they are directed by CMO staff to do so.*

At pick-up, staff will ask for a valid ID to check if the individual is on the authorized pick-up list. EITHER A PARENT OR AN AUTHORIZED ADULT LISTED IN ULTRACAMP MUST SIGN EACH CAMPER OUT EACH DAY! We will only release a camper to someone listed on your pick-up form. An attempted pick-up by an individual not listed will result in a member of the camp leadership team calling the primary or secondary phone number on file for confirmation. If you are not picking up your camper, please have your phone on and accessible in case of a call.

Adventure Academy – ZipZone and Friday Add-on Option

At one point during the week, your camper will walk to ZipZone to play on their Adventure Park. Each camper must have a ZipZone Waiver on file (<https://waiver.smartwaiver.com/w/56d8753f5bc3b/web/>); *please fill out a new one each summer*. If your camper does not have a waiver on file, ZipZone will not allow them to participate. If there is inclement weather and ZipZone cancels, there will be no refund or reimbursement to Adventure Academy campers.

If the Friday ZipZone Add-On tour is canceled due to weather, you will receive a full refund. Camp Mary Orton will automatically refund your ZipZone Add-On amount to your payment method on file. Camp Mary Orton will process refunds; please do not contact ZipZone directly. If you cancel your ZipZone add-on, you may receive a refund minus a \$15.00 admin fee. The deadline for ZipZone Add-on cancellations is seven (7) days before your camper's ZipZone add-on date.

Frequently Asked Camp Questions

My camper has special dietary needs; how do you accommodate them?

Campers are served lunch and snacks daily. If your child has any special dietary needs (allergies or restrictions), please include them when you register through Ultracamp (our camper registration program). We work to provide suitable substitutions for allergies, dairy or gluten sensitivity, vegetarian, vegan, and other dietary restrictions. There are limitations to what we can offer, and campers may not like the options provided, so please consult program staff if you have questions.

I am running late for pick-up. What should I do?

We ask that you honor the scheduled times of 9:00 AM and 4:00 PM as closely as possible. We recognize that work and traffic can affect everyone's best efforts to be on time, so we have built a 15-minute grace period into the end of our daily schedule for late pickups. If you are running late, please call the Camp Mary Orton Summer Camp phone number listed at the end of this handbook.

After the 15-minute grace period, a \$15.00 fee will be charged every 15 minutes, or portion thereof, that your camper remains at camp. This fee will be applied to your UltraCamp account and automatically charged to any payment method on file.

Are campers outside all day? What about water breaks, sunscreen, or heat index?

YES! Your child will spend the entire day outside unless the weather is severe. On hotter days, we use our natural shade, take plenty of water breaks, and maybe even throw in some water games. We will remind campers to fill water bottles and apply sunscreen regularly. We ask that campers can apply their own sunscreen. Spray sunscreen is the best for camp! When Mother Nature provides us with some rain, or what we call "liquid sunshine," our camp day proceeds as usual. Please pack rain gear!

All campers are moved to covered or indoor areas when there are thunder and lightning. In the summer, these occurrences are usually brief, but if campers spend a prolonged period indoors, we will provide alternative indoor games and activities if the weather is severe enough to move the entire camp indoors.

Camp Mary Orton Day Camps are outdoor camp programs, so all our activities are weather-dependent. We do our best to flex activities around thunder and lightning, but we can't guarantee that we will fit in every scheduled activity in the event of a thunderstorm.

My camper isn't a strong swimmer. How deep is your pool & do you have Lifeguards?

Our pool is 3.5' to 7.5' deep. Campers must pass a swimming test to swim in the pool's deep end. We have two (2) or more guards on duty during swim time along with our counselors. Campers will swim daily (except Adventure Academy on Friday), so please pack a bathing suit, goggles, and towel.

My camper has friends also coming to camp. Can I request they are in the same group?

We no longer accept friend requests for camp placement. Campers are grouped intentionally by age, developmental level, and staffing ratios to support safety, inclusion, and positive group dynamics. This approach helps campers: meet new friends, build social skills, and have a more inclusive camp experience. Our staff are trained to support campers socially and help them adjust.

More information about Family Nights, including dates and activities, will be communicated closer to the start of camp.

CMO Policies

Late Drop-off & Pick-up

Please honor the scheduled program times. For any camper not picked up by 3:45 pm for Discovery Day Camp and 4:15 pm for Adventure Academy (12:15 PM on Friday), a \$15.00 fee will be charged every 15 minutes or portion thereof that your camper remains at camp. This fee will be applied to your UltraCamp account and automatically charged to the payment method on file.

Refunds

Deposits are never refunded except when a program is canceled by Camp Mary Orton. Registration fees minus the deposit can be refunded when cancellation occurs at least 14 days prior to the start of your child's camp session. Participants assume risk and responsibility for changes in personal schedule or health.

Cancellations

To cancel registration, please contact the Enrollment Coordinator at 614.706.2233. You must speak with Camp Mary Orton administrative staff to cancel. A voicemail message will not be considered proper notification of cancellation for refund purposes. Please note that your \$75 deposit is non-refundable if you cancel your registration.

Changing Weeks

Because of the additional cost of processing a change request, a \$15 fee will be assessed for changing your campers' week once you have registered.

Forms

Camp Mary Orton uses UltraCamp to collect camp forms electronically, including waivers, pickup authorizations, and medical and emergency contact information.

Health forms are due no later than 14 days prior to the beginning of your camper's session. A late \$15 late fee will be charged to the payment method on file for forms not submitted by this point. Campers will not be permitted to be at camp with incomplete forms.

Communicable Disease Policy

Being outdoors in small groups, regular hand washing, sanitizing of surfaces, and ongoing health monitoring by camp staff are our primary defense against the spread of communicable diseases at camp. We ask that families do their part by keeping campers at home if they are showing signs of illness within a 24-hour period prior to coming to camp. Campers will be isolated, and parents will be notified to pick them up if they show signs of illness, such as:

- A temperature of at least 100.4 in combination with at least one other symptom of illness
- Diarrhea
- Severe coughing
- Difficulty breathing
- Evidence of untreated lice
- Sore throat or difficulty swallowing
- Vomiting more than one time or when accompanied by any other symptom of illness

If youth come to camp with symptoms of illness or a suspected contagious issue, they will be removed from their group, and parent/legal guardian will be called to pick them up from the program site and follow the above instructions regarding their care.

Confirmed contagious issue or illness (lice, pinkeye, COVID-19, chicken pox, etc.) may require a quarantine period and/or Doctor's note for proof of treatment before participants can return to program.

Asthma & Allergies

Camp Mary Orton takes place in an outdoor environment that contains many possible environmental triggers for a respiratory or allergic condition. If youth have asthma requiring a prescribed inhaler or an allergy requiring an EpiPen, these medications must be at the program site for youth to participate in program. Failure to provide doctor prescribed inhalers and/or EpiPens for your enrolled participant's access during program hours could result in your participant being asked to stay home until their medication is available at the program site.

Mandated Reporting of Suspected Child Abuse or Neglect

Godman Guild and Camp Mary Orton are mandated reporters under Ohio law. If there is concern of possible child abuse or neglect, we are required to notify Franklin County Children Services (FCCS). Our focus is always on keeping children safe and supported.

Removal from program

Godman Guild and Camp Mary Orton are committed to creating a safe, positive, and supportive environment for all campers. We never want to remove a camper from the program, and whenever possible, we will partner with families to address concerns through communication and corrective steps.

However, a camper may be removed from Camp Mary Orton programming if behavior becomes unsafe, disruptive, or prevents staff from maintaining a safe environment for all participants.

Reasons for removal may include (but are not limited to):

- Repeated failure to follow camp safety rules and expectations
- Disrespectful or non-compliant behavior toward staff
- Bullying, harassment, verbal threats, physical aggression, or violence toward self or others
- Ongoing behaviors that significantly disrupt the camp experience for others
- Leaving supervision or running away from staff or program areas
- Possession or use of tobacco (including vapes), alcohol, or illegal drugs
- Sexually inappropriate behavior or sexual harassment of campers or staff
- Possession of a weapon or threatening use of a weapon
- Threats of self-harm, self-harming behaviors, or suicidal ideation
- Parent/guardian or family representative displaying threatening or abusive behavior toward staff or participants

It is important to us that your child has a safe, successful, and fun experience at summer camp. We are honored that you chose Camp Mary Orton to be part of your camper’s summer.
