(PLEASE NOTE: If you prefer that your child’s image not be used as described above, please let the camp office know, in writing before the start of camp.)
- I agree to submit a completed medical form with proof of immunizations and booster doses, signed by a licensed physician within one year of the child’s start date at camp before the start of camp.
- I have read and reviewed with my child the Behavior Management Statement and agree that my child’s attendance at Brimmer Summer Camp is contingent on his/her adherence to the behavior guidelines.
- TRANSPORTATION TO POOL: I authorize and agree to permit my camper(s) to be transported by bus vehicle between Brimmer Summer Camp located at The Brimmer and

May School (“Brimmer”) and Pine Manor College or to the Chestnut Hill School in order to swim in the pools located there.

- I understand that Brimmer Summer Camp strives to provide the safest facilities, equipment and supervision possible. At camp, children participate in many different activities throughout the day and summer that do involve risk. Those activities include: SWIMMING, WATERPLAY, ARCHERY (children over 6 years old), CLAY, ARTS & CRAFTS, DRAMA, YOGA/MOVEMENT, SPORTS & GAMES, PLAYGROUND, NATURE/SCIENCE, MUSIC, AND OTHERS. It is always a possibility that serious injuries can occur while involved in a camp activity, despite all of the precautions taken. By signing below, you are acknowledging these risks and agreeing to allow your child to participate. (If you wish to preclude your child’s participation in any activity, please notify the camp, in writing before the start of camp.)
- Fully understanding the inherent risks in any camp-related activity, and in consideration of Brimmer Summer Camp permitting my camper to participate in activities related to Brimmer Summer Camp, I agree to assume all risks associated with my child’s or children’s participation in the Brimmer Summer camp program, and agree to hold Brimmer and May School, Brimmer Summer Camp and its staff and directors and third party partners free from any and all liability, actions, causes of actions, debts, claims, or demands of any kind or nature which may arise by or in connection with, my participation in any activities related to the Brimmer Summer Camp program.
