One-way service will be provided Monday through Friday in compliance with the Brimmer Summer Camp schedule. Brimmer does not guaranty actual pick-up times, as all times are estimates based on variables to include traffic and weather conditions. However, Parents/Guardians are responsible for ensuring that the camper is situated in plain view at the selected designated pick-up location by no later than the scheduled pick-up time ready to board the bus vehicle. The bus vehicle will not wait for any late camper, as the bus must maintain its transport schedule.

Brimmer will endeavor to provide prompt notice as soon as possible via email in the event of a delay in or cancellation of bus service on a particular day. In the event of a

cancellation of bus service on any particular day, Parents/Guardians will be responsible for arranging alternate transportation.

Parents/Guardians shall be solely responsible for supervising the safety of the camper while waiting for the bus vehicle to arrive at the selected designated pick-up location. Parents/Guardians shall provide Brimmer with prompt written notice of any injury sustained by any camper during transport. No food or drink items shall be permitted on the bus vehicle during transport. No cellphone, personal electronic devices, or personal musical devices shall be used during transport. All campers at all times shall abide by all instructions of the bus operator and any personnel riding on the bus. Any camper who does not comply with the rules of transport may be subject to termination of transport services in the sole discretion of Brimmer.

In consideration of Brimmer providing the bus transport services and as an express condition of acceptance of bus transport services, Parents/Guardians waive, release, and discharge Brimmer and its officers, trustees, employees, and agents from and against all claims, damages, liabilities, actions, payments, lawsuits, demands, costs, and expenses of every nature and kind in any way arising out of or related to the transport services. Parents/Guardians expressly assume any and all risks associated with transport services.
