Camper Accounts


Enclosed is an invoice of your camp fee account showing your camp dates, your total camp fee and any payment(s) and credits to the account. ALL PAYMENTS MUST BE SENT TO NLOM at 27416 Ranch Road, Ashland, NE 68003. Payments must reach us TWO WEEKS prior to your child's camp session if our records at check-in are to reflect payment made. Please do <u>not</u> send payment to Lodgepole; all of our camper records are in Ashland.

Arrival

Check-in time is 3-4 p.m. (mountain time). Campers will deposit any spending money in the Camp Store and check in any medications brought to camp. Early arrivals will be asked to wait outside until 3 p.m. to allow staff time for final preparations.

Getting to Camp

Sullivan Hills Camp is located at 4236 Road 149, Lodgepole, NE. Directions to camp can also be found at Sullivan Hills.org/contact-us.



Medications

American Camp Association Standards require all prescription and non-prescription medications to be kept locked and dispensed only under the specific directions of a licensed physician. All medications for youth and adults must be in the original container with the physician's name on it. The directions/dosage on the container is what we are required to follow. All medications must be turned in to Health Care staff at check-in. The only exceptions are medications for lifethreatening conditions, which may be carried by the camper or counselor after a discussion with our Health Care staff.

Camp Store

Campers will have an opportunity to go to the Camp Store each day. The Camp Store has camp souvenirs, stationery and stamps. We do not sell pop or candy.

Campers who have money for the Camp Store will open a camp bank account at check-in. Purchases will be deducted from their account and the balance refunded to them on the last day of the camp session. The store will also be open on the last day of the session.

- Hair dryers, straighteners, etc.

"Not Allowed" items will be held by staff and returned at the end of the week. NLOM reserves the right to search personal belongings, with the camper present, if we believe items not allowed have been brought to camp. Illegal drugs, tobacco, alcohol, knives, firearms, fireworks, or anything that might be perceived as a weapon are not tolerated at camp. NLOM reserves the right to ask any person found with these items to leave camp. Parents are responsible for getting any child asked to be sent home with no compensation or refund.

Camper Email

You may send your child email. It must be received by 9 a.m. for delivery that day. Our printer is black and white

- no fancy art or forwardings please. Mail MUST be addressed to: SullivanHills@ hotmail.com and in the "subject" field be sure to put your child's first and last name.



Campers will NOT be able to reply to email while they are at camp.

Camper Mail

Campers love getting mail, although they may not write to you as often as you wish! Please keep your messages positive and upbeat. Your camper may get homesick, but it will pass. The first letter you receive may sound apprehensive, but don't worry; by the time the letter reaches you, your child has probably forgotten what they wrote and is having a great time! Do not send packages containing gum, candy or food. Any such items will be held for the camper to pick up on closing day.

We also have an in-camp mail box available when you bring your child to camp. You can drop mail in it and it will be delivered on Monday, or whatever day you indicate on the mail. In-camp mail doesn't require any postage.

Lost and Found

We have many campers each week, and personal gear can get mixed up. **Be sure to mark all items brought to camp.** Campers should also help with the packing, so they know just what they brought with them.

Lost and found will be kept for two weeks. Unclaimed items are donated to charity. Please contact Sullivan Hills Camp at 308-483-5804 immediately if you discover something was left behind.

In Case of Severe Weather

Sullivan Hills Camp has a storm shelter and we monitor weather conditions carefully. We will notify parents via email and Facebook when appropriate, so please do not call camp during a storm. We need to keep our phone line open, and will be busy taking care of campers.

In Case of Illness

Health Care Staff are at camp 24 hours a day, and all of our summer staff are certified in First Aid & CPR. Records of all medications and first aid treatment are filed with the site coordinator daily. If there is an emergency or serious illness parents will be notified by our volunteer Health Care Staff or Site Coordinator.

Charges for medical services are usually billed directly to parents. Camp carries secondary insurance for camprelated accidents or illnesses. We do not cover treatment for pre-existing conditions.

Departure

Camp will wrap up on the last day at **2 pm (mountain time) with a closing worship**. Families and friends are encouraged to come and worship with us. **Campers must be picked up by 3 pm.**
