# **Drop Off & Pick Up**

JV Camp check-in is Sunday, August 5<sup>th</sup> at Camp Carl beginning at 2pm and ending at 3pm.

#### When you arrive...

You will be directed to a parking space where you'll place your camper's luggage behind your car and wait for one of our staff members to tag it and take it to a shuttle. You will then be directed to the lodge where you will check your camper in. For the safety of all campers, a lice check will be performed on all children in the lodge according to our policy.

### Once you've completed check-in...

You can proceed to your camper's assigned cabin. At the cabin, you will meet your camper's counselors, help your camper get settled, and discuss any special concerns with their counselors. Be sure to make your send-off short and positive. The focus should be how much fun your camper is about to have at camp, rather than how much you will miss them. Otherwise, campers tend to start camp feeling worried about being away from home, instead of excited about camp. Your camper should then stay with their counselors while you head back to your car.

#### **Lost and Found**

Claimed items will be returned C.O.D. Items will be held for one week. Unclaimed items will be donated to charity. Please note that Camp Carl and Faith Family cannot be held responsible for lost or broken articles.

# **Packing Details**

\*\*Due to SEVERE ALLERGIES, no peanut products may be brought to camp. Peanut products may be severely hazardous to your camper's cabin mates\*\*

### **Helpful Hints**

Please pack using a suitcase or duffle bag.

Don't buy a lot of new clothing—this is camp, and we will most likely get wet and dirty!

Use Ziploc bags to waterproof items.

Don't send anything that you consider irreplaceable.

Clearly and boldly label all your child's belongings.

#### **Dress Code**

Strapless clothing, spaghetti strap tank tops, short shirts, halter tops, t-shirts with large cut outs, and mini skirts are not allowed. All shorts must be a modest length (fingertip length) and we have a NO ROLL rule. For girls, one-piece swim suits are preferred, however, modest two-piece suits may be worn under a tank top. For boys, swim trunks are required; no cutoffs or speedos.

# What to Bring (Please be sure to clearly mark all belongings with your child's name):

Clothing for each day (send clothes that are okay to get dirty)

- O T-Shirts/tops (no strapless, spaghetti strap, or halter)
- O Shorts (modest length), capris
- O Blue jeans/long pants (may be required for some activities)
- O Socks & underwear
- O Pajamas
- O Raincoat/poncho
- O Lightweight jacket/fleece/hoodie
- O Swimsuit (boys: swim trunks only; no cut-offs or speedos. Girls: modest swim suit that covers midriff)
- O Gym shoes/tennis shoes (two pairs recommended; comfortable, closed-toed shoes are best)
- O Flip flops or water shoes for shower
- O Baseball cap/hat
- O We will be having a glow night one evening at JV Camp if you would like to send along white or neon articles of clothing and accessories (we do not recommend white clothing for camp in general).

Laundry bag for dirty clothes and plastic bag for wet items

Twin bed sheets/blankets/sleeping bag

Pillow and pillow case

Bath towels and washcloth

Beach towel

Toiletries (travel size soap, shampoo, conditioner; toothbrush & toothpaste; deodorant; etc.)

# **Packing Details continued**

You may send snacks in sealed containers with your camper, but they are not necessary. <u>Peanut products are prohibited</u>. Campers will be served three meals a day plus an evening snack. Additionally, money for the afternoon snack shop can be added to your camper's account online at <a href="https://campcarl.life/">https://campcarl.life/</a>.

### What NOT to Bring to Camp

- Any electronic device that can access the internet breaches our security policy. If discovered by a counselor, it will be collected and stored until the end of camp.
- Cell phones, computers, iPads, tablets, DVD players, and handheld video game systems
- Alcohol, illegal drugs, tobacco products
- Weapons (including pocket knives and multi-tools)
- Fireworks
- Personal sports equipment (everything you need will be provided for your activities)

Please do not pack anything valuable and do not over pack. **Send old items that will not be missed if they get lost**. Camp Carl and Faith Family Church are not responsible for lost, stolen, or damaged items.

### **Activity Information**

Camp is packed with wall-to-wall activities and fun-filled moments. Every moment is planned and intentional—from the minute campers arise until they hit their bunk at night. Activities include archery, the lake's giant inflatables (iceberg, slide, and trampoline), canoeing, kayaking, paddle boarding, a wooded initiatives course, basketball, horse-back riding, gaga ball, ultra ball, a huge outdoor swimming pool with water slides, a climbing tower and zipline, creek exploration, and more!

# **General Policies & Guidelines**

#### **Communications**

We check our e-mail regularly and respond in a timely manner. You may also call (330) 315-5665 for Camp Carl, or (330) 305-0925 for Faith Family.

### **Camper Check-Out Policy**

Campers will be released only into the care of the adult assigned in the registration process. If other than the parent, we require an Alternative Pick-Up Form to be completed online or during check-in.

### **Contacting Your Camper**

If an emergency arises you can call our office 24 hours a day at (330) 315-5665 and a member of our staff will assist you. If your camper needs to contact you, we will facilitate that as well. For security reasons, no unauthorized visitors or parents are permitted during camp.

# **Health Information**

### **Special Dietary Requirements**

Camp Carl is concerned about your child's health and will gladly work with you regarding special dietary restrictions and requirements. We can accommodate a gluten-free or dairy-free diet. We allow each camper to eat from a buffet line where there will be multiple options for them to choose from.

# **Lice Policy**

For the safety, health, and comfort of all campers, no child with untreated lice (bugs) or lice eggs (nits) on their person or belongings will be admitted to camp. Each child will be checked for lice/nits upon arrival to camp. To properly perform a lice/nit check, ponytails must be removed prior to check. We will do our best to do lice checks around braids, but any signs of lice or nits will require that braids be taken out. If lice/nits are present, they must be treated prior to admittance to camp. Parents are responsible for treatment of both their camper's belongings and camper's head when lice and/or nits are found at camper check-in. If not properly treated, camper will not be permitted to attend camp and there will be no refunds.

#### **Health Care Reminders**

At Camp Carl, safety is our number one priority. Your child's safety and health are of the utmost importance to us and we will provide professional and responsible care while they are at camp. To maintain our standards of excellence, we follow the regulations of the American Camp Association. Below are some suggestions that will improve your child's experience and expedite your check-in process.

- No Nit, No Lice Policy
  - O Please inspect your child(ren) 48 hours prior to camp for lice and/or nits. If found, please treat and remove ALL nits so that they can be admitted to camp. (There are several resources available that can assist you in this process. For your convenience, here is a sample website you can review: <a href="http://www.wikihow.com/Check-a-Child's-Hair-for-Lice.">http://www.wikihow.com/Check-a-Child's-Hair-for-Lice.</a>)
  - O Please note that every child is also checked on their arrival day by a counselor and/or Health Care Professional.
- Medication Specifications
  - O All medications are required to be in the original packaging and contain only the medication identified on the container. Do not put two or more different medications in the same container.
  - O If your child requires a prescription medication, the prescription label must be legible with the camper's name on it. Please do not use old bottles or those belonging to another family member, as they will not be administered per state law.
  - O Please bring all medication in a labeled gallon-size Ziploc bag.
  - O Please check the medication's expiration date. Expired medication will not be administered per state law.
  - O The ONLY medications that are permitted to be kept with the counselors are RESCUE inhalers and EPI pens. These are the only medications that our counselors are trained to administer. If you have any questions, please feel free to contact our Health Care Doctor during check-in.
  - O We do not allow campers to keep these medications themselves as it poses a threat to other campers. A counselor that has your child's rescue medication will be with your child at all times. The counselors are allowed to keep glucometers.
  - O If your child's medication will be sent with someone who is not familiar with the dose and administration time, please be sure to send a note with the exact information. Medication administration times are during Breakfast, Lunch, Dinner and at Bedtime. Please choose which med call times you will prefer.
  - O All medications will be returned on Wednesday. Medications that are left over are disposed of so please be sure to stop by our Medication Return table in the Lodge on Wednesday.

# **Health Information continued**

- If your child has surgery, a fracture or serious injury within 6 weeks of camp, please contact our office as a physician's release will be required.
  - If your child has had a contagious illness 7 days prior to camp, please contact our office to discuss specifics.

  - O Requires any injectable medication
  - O Any seizure disorder
