Camp Orchard Hill is pleased to provide you with transportation services to our Day Camp!

As with all our programs your child's safety is most important to us. We will have a Camp Orchard Hill counselor on each van or bus to check your camper in and out and to supervise the children while coming to and from camp. Buses will run with reduced capacity this summer in order to allow for social distancing. Vehicles will be cleaned and disinfected daily in accordance with CDC guidance. A contactless health screening will take place before your child is allowed on the bus (see Health Screening details below). If you need to send communication or payment to the office, please provide it to the bus check-in team in a sealed envelope with your child's name on it.

2020 Health Screening – Before your child gets on the bus, or while your child is still in carline, a staff member wearing PPE will take your child's temperature with a contactless thermometer and ask three questions:

- Have you had a temperature of 100.4 or greater in the last 72 hours?
- Have you experienced coughing in the last 72 hours?
- Have you experienced shortness of breath in the last 72 hours?
- Have you or anyone in your household had contact with a person with a positive COVID-19 infection?

If your camper registers a temperature of 100.4 or greater, our check-in team will take a second scan or refer you through the carline to a designated parking spot for a second scan. If the camper continues to register a temperature, your camper will not be able to stay at camp for the day.

For those who have a fever of 100.4 or greater and multiple COVID-19 symptoms, a written physician's clearance will be required for re-admittance to camp.

In order to give your child the safest and most efficient ride to camp we have designated centrally located stops for pick-up and drop-off. If there are enough campers, we will consider additional stops and will revise the pick-up and drop-off times.

For everyone's safety we have the following rules for the bus. Please discuss these with your child.

1. Campers will Parents are responsible for getting your child on and off the van/bus. Please look for a Camp Orchard Hill sign in the window of the bus. You must sign your child in and out with the van/bus counselor each day.
2. Campers need to listen and obey the van/bus counselor and driver.
3. Campers need to remain seated and fasten a safety belt (for vans).
4. Once seated do not change seats.
5. Tell your counselor if you have any problems on the van/bus.
6. Do not leave your seat to get off the van/bus until the vehicle has come to a complete stop.

If you cannot meet the van/bus or cannot attend camp on a particular day, please call the camp office at (570) 333-4098. Please know that voicemails are checked regularly outside of office hours. The bus or van will wait at each designated stop until the scheduled departure time, and then the bus must continue on its route.

Any changes in the transportation schedule prior to the start of camp or the camp week will be communicated via email. In the case of an emergency that would affect camper pick up or drop off time and location, we will contact you via text messaging and/or phone call.
