

By registering for a Handwork at Home - Virtual Workshops, I hereby give my child(ren)/wards, hereafter referred to as "child," permission to participate fully in The Handwork Studio's, Handwork at Home - Virtual Workshops, hereafter known as "H@H"

## I understand and agree:

- I retain full supervisory responsibility for any and all activities that happen as a part of H@H.
- Staff refers to adults (18+) who have been screened, approved, and trained by The Handwork Studio.
- Staff are not able to provide supervision for my child.
- There are risks associated with participating in the H@H activities, including, but not limited to, using scissors, pins, needle-felters, etc. A complete listing of inherent risks is not possible and some risks cannot be anticipated.
- If my child is hurt while participating in any H@H activity or activity recommended by camp H@H, I will assume full responsibility.
- H@H workshops are live sessions. Only registered participants and approved staff will be allowed to enter and to participate.
- The Handwork Studio will provide strict security protocols while using live online sessions but online security for my child is ultimately my responsibility and I will maintain and supervise any online accounts that my child may participate in with H@H.
- For all H@H live sessions, I will ensure that my child is appropriately dressed and that the computer and camera that they are using does not show anything inappropriate.
  - Virtual backgrounds or blurred backgrounds are allowed. If staff notice something on your child's video that staff determines is not appropriate, a staff member will reach out immediately to discuss the course of action.
- For all H@H live sessions, I will ensure that my child is participating in an appropriate work environment, i.e. tables or floors are encouraged. Soft surface, i.e. like a bed or couch discouraged.
- Appropriate behavior for participants will be expected. Staff will review appropriate and inappropriate behaviors with participants at the beginning of each workshop. Bullying, including cyberbullying, during a workshop or outside of a workshop is not appropriate. A staff member will reach out immediately to parent/guardian to discuss the course of action, including and not limited to temporary or permanent removal from H@H.
- That my child may be in either a screenshot and/or video clips. These artifacts may be used by The Handwork Studio for current or future marketing purposes. Before either a screenshot or a recording happens, participants will be notified.
  - You will have the opportunity to opt-out of photos and videos when filling out your registration form. Instructions will be given on how to handle a photo/video opt-out. The room will be told when the recording is stopped.

## Handwork at Home - Parent Acknowledgment

- That my child and myself and any co-parent or guardian(s), are not allowed to take, and shall not take, any photographs, video, or other recordings of other children or other parents/guardians participating in camps, events, or programs without their express consent, and are not allowed to transmit, upload, or post such content online or electronically including on any social media or similar site, or use or publish such content in any non-personal media such as a book, video, film, television program or publicly viewable website. Upon the Camp's request, I agree to delete and/or remove such content from any device, site, platform, or other media, if, in the Camp's sole and absolute discretion, such content and/or the manner in which it is presented violates the terms of this agreement, is objectionable, inappropriate, or violates the privacy rights or right of publicity of others.
- The Handwork Studio has the right to record workshops for internal security purposes only. Recordings **will not** be shared or used for marketing purposes.
- To follow and to ensure that my child follows The Handwork Studio's Policy that states:
  - Any private (one to one) electronic communication between staff and youths, including the use of social networking websites like Facebook, Instagram, Snapchat, instant messaging, texting, etc is prohibited and The Handwork Studio will be notified if a staff member has personally reached
  - All communication between staff and youths must be transparent and public. Example:
    - they may communicate on H@H managed group sites where anyone who is a member can see the conversation
    - Email communication is preferred to be between the parent and The Handwork Studio administration team.
    - They may communicate in private media set up for two-way classes and discussion groups. Such as a zoom class. These will be always facilitated by at least two approved adults with at least two children and one approved adult in each breakout room. The overall facilitators may join any breakout room at any time.
- It is my responsibility to provide any equipment needed for virtual programs, such as a computer, tablet, internet access, headset, earphones, microphone, digital camera, supply kits, etc. I also understand that any damage to said equipment is the sole responsibility of the owner of said equipment. I will not hold The Handwork Studio responsible for any damage that may happen during H@H.
