Your student's visit is sure to be filled with new experiences and memories. Our mission is to:

To help us accomplish our mission, here are some tasks and helpful notes as you and your child prepare:

- Review this packet and pack accordingly.
- If your child needs to take medication(s) during the trip, please do one of the following:
  - Input your students medication information in their profile when you register in UltraCamp
  - OR print (or ask the school to print) the Medication Order Form (page 5) and submit a completed copy with the med(s) to a teacher before the trip.
- If any form is incomplete your child might not be able to participate and/or be sent home early.
- If you need to contact your child outside of normal business hours from 4:30pm-8:00am regarding a family emergency or urgent issue, please call 951-659-2455 ext 22 for the Health Center/Infirmary. If you can't reach a staff person at that extension then call 760-408-3408.
- Please contact your school and/or visit our website (<u>www.pathfinderranch.com</u>) for more information about our education program. Thank you for your support and we can't wait for your child's trip!

## **ARRIVAL & ACTIVITIES**

### **Arrival Day**

Students must bring a sack lunch on their arrival day. Nut products are **NOT** allowed on campus for the safety of staff and other clients who have nut allergies, so please **DO NOT** pack any nut products in your child's sack lunch. Ask your trip coordinator if the school will provide these sack lunches. Pathfinder will provide all other meals during the trip. Students will also have a campus orientation and review the behavior expectations.

### **Activity Restrictions**

Please be sure to complete the online Activity Acknowledgement Form and include any physical or activity limitations for your child. For the safety of all participants and staff, Pathfinder Ranch may restrict/adapt participation for individuals with the following conditions in certain activities:

- Over 250 lbs in body weight (only applies to Horseback Riding and Ascent activities) Pregnancy (only applies to Horseback Riding and Ascent activities)
- Cardiac disease
- Received an organ transplant
- Currently experiencing abdominal organ enlargement (e.g. Mononucleosis)
- Active orthopedic and/or joint problems (e.g. Rheumatoid arthritis, recent fracture or sprain, or current sutures or staples)
- History of head, neck, or back injuries
- Any condition that a physician has determined creates a limitation to physical activity or if you think that participating in recreation activities will aggravate any previous medical condition

## **HEALTH SERVICES**

Please be sure to include all pertinent medical information in the online Health History Form. Pathfinder's Health Staff is available 24 hours a day to address basic first aid, minor illnesses, and distribute student medications. EMS is about 5 minutes away for advanced care, life support, etc. Parent/guardians will be notified if their child has a severe illness or injury while at camp that requires care beyond basic first aid (e.g. severe bone or muscle injury, breathing emergency, loss of consciousness, paramedic intervention, or other condition requiring off-site treatment). Parent/guardians will also be notified for other major concerns (e.g. evacuation, suicidal ideation, violence against self or others, suspicion of lice, poor behavior, or other situation the school faculty determine contact is necessary). Homesickness is a common issue that intensifies if a child talks to family at home, so Pathfinder staff and/or the school faculty will call a parent/guardian only when necessary. If a parent/guardian does not want certain medical treatment for their child, they must either add this information specifying the action to be taken in the online Health History Form or via a signed fax (951-659-0351). If you have additional health questions, please call 951-659-2455 ext 22.

Some of Pathfinder Ranch's medical limitations and special notes regarding chronic conditions include:

- We do not employ a registered nurse or physician, and therefore, our staff cannot make diagnoses.
- Our staff cannot administer most needle injections (e.g. insulin), but our staff are trained to administer epinephrine auto-injectors if needed. The group's faculty will determine who should carry emergency medications (e.g. student, chaperone, faculty) during their trip.
- Our staff is not able to supervise or care for participants with chronic medical conditions (e.g. type 1 diabetes). If your child requires care outside of our scope (injections, blood glucose monitoring, hygiene assistance, 1-1care), please complete the Campe Chronic Conditions Letter (ask your school faculty for a paper copy) and confirm arrangements regarding your child's care with the school's faculty. We recommend a parent/guardian attend to assist their child.

### **MEDICATIONS**

- Pathfinder Ranch has standing orders approved by a physician to carry and administer the following over the counter medications as needed without a Medication Order Form:
  - Ibuprofen
  - Acetaminophen (eg Tylenol, Dayquil)
  - Phenylephrine (eg Sudafed, Dayquil)
  - Loratadine (eg Claritin)

- Cetirizine (eg Zyrtec)
- Diphenhydramine (eg Benadryl)
- Dextromethorphan (eg Delsym)
- Antacids and Pepto-Bismol
- If you plan on sending medications for your child to take during their trip, even vitamins or medical cream, please input the medication information into your student's Ultracamp profile, or submit a completed Medication Order Form, (print page 5 of this packet or ask the school for a paper copy) along with the medication to a teacher before the trip.
- **DO NOT pack** any medications in your child's luggage. Put the medication(s) and form in a plastic bag labeled with your child's name and give it to a teacher before your trip.
- All medication must meet the following conditions:
  - Prescription medications must have a legible Rx label with a visible expiration date.
  - The **dosage and administration times** on the form must match the directions on the label
  - Over the counter medications must be age appropriate

- If the medication does not meet the above requirements, the medication be accompanied by the **paper medication order form and signed by the student's physician**
- All non-emergency medications must be locked up during the trip. However, the school faculty is responsible for determining who (e.g. student, chaperone, faculty) should carry and be responsible for emergency medications (e.g. inhaler, epinephrine).
- A school medication form can be submitted for emergency meds instead of the Pathfinder med form.
- Please mark inhalers and epinephrine auto-injectors with the student's name in **PERMANENT** MARKER.
- **DO NOT** pack any medications in your student's luggage. The teachers will decide who should carry your child's emergency medication during the trip and on the bus ride home.

### FOOD SERVICES

Please be sure to include as much dietary information in the online Health History Form so we can make appropriate meal accommodations for your child. Pathfinder's Food Service Staff can accommodate several special diets including vegetarian, mild nut allergies, gluten free, lactose free, no shellfish, and no pork. However, we sometimes serve food items that have been processed in facilities that also process nuts. If your child has a severe nut allergy, multiple restrictions, or something not listed above, please contact our Food Service Staff at 951-659-2455 ext 28.

### **VACCINATIONS**

California law requires all children enrolled in state schools, both public and private, to have or receive before enrollment certain doctor-recommended immunizations. Your child will likely be attending as a student of a California school and are familiar with these requirements. We would also like you to be aware of Pathfinder Ranch's position on vaccinations. Guests attending programs sponsored by Rental Groups (e.g. Outdoor Education) are not under the direct supervision or authority of Pathfinder Ranch and should contact their sponsoring Group regarding vaccination requirements. Groups renting our facilities are encouraged to have an MMR vaccination screening process as well as a policy on vaccination requirements to participate in Group sponsored events (e.g. field trips). Pathfinder Ranch will report any suspected virus-related risks associated with any attending group members to the group leader as well as the Department of Health. Please keep in mind that any camper leaving the site due to an identified or suspected communicable health issue will be required to obtain signed approval from a licensed doctor to return to camp.

### **COVID - 19 POLICIES AND PROCEDURES**

Prior to your trip, please discuss these with your students. As new information becomes available, and county/state public health officials and the American Camping Association update industry guidance, our precautions, policies, and procedures may change. In the event that changes are made, you will be notified by email and may be asked to indicate receipt and acknowledgement of these changes in your registration account.

## **Packing List**

- Sack lunch on arrival day is provided by participants (students and adults) and/or the school. Pathfinder staff will provide meals for the rest of the group's stay. For the safety of staff and clients with severe allergies, we are a nut free program, so please **DO NOT** put any nut products in your child's sack lunch.
- Students must carry their own luggage, so pack their equipment into **one** suitcase or bag. Keep sleeping bags separate and do not bundle luggage items, because it makes loading the buses/cars very difficult.
- Label all personal items and expect them to possibly get lost, dirty, and/or broken.
