**Acknowledgment of Risk**

I, in my legal capacity as the parent/guardian of the minor named below, do hereby acknowledge and agree that participation in Camp Gan Israel’s activities comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with Camp Gan Israel’s participation, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with participating in Camp Gan Israel and that said list in no way limits the operation of this Agreement.

In consideration of the named minor’s participation in Camp Gan Israel’s, I, the undersigned parent/guardian of the named minor, agree to INDEMNIFY AND HOLD HARMLESS Releases from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to the named minor’s participation in Camp Gan Israel.

I hereby certify on behalf of myself and the named minor that I have full knowledge of the nature and extent of the risks inherent in Camp Gan Israel’s participation and that I, on behalf of myself and the named minor, am voluntarily assuming said risks. I understand that I and the named minor will be solely responsible for any loss or damage, including personal injury, property damage, or death, the named minor sustains while participating in Camp Gan Israel’s and that by signing this agreement I, on behalf of myself and the named minor, HEREBY RELEASE Releases of all liability for such loss, damage, or death. I further certify that the named minor is in good health and has no conditions or impairments, which would preclude his/her safe participation in Camp Gan Israel’s.
